

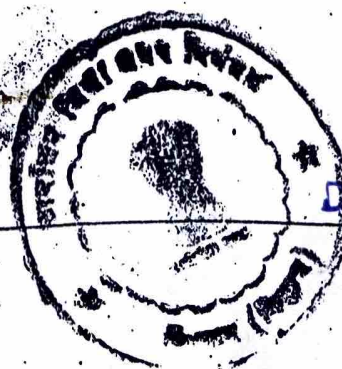



college, professional/ technical training institutions,
school or vocational institution (s) of any class or category
without any discrimination with any class or section of
gender of the society and with a non-profit making
intention. However if profit shall arise that shall be

2. To run, control, administrate and manage and such type
of schools at other places and other types of institutions

for these institutions and to provide financial assistance
for the development and betterment of these institution

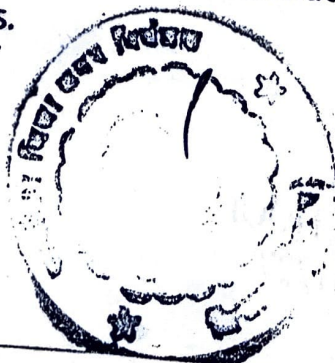

3. To run establish, open, maintain a boarding house, hostel, staff quarter, auditorium, play ground, stadium, health club, health centre, hospital, music centre for the students, staffs & members.
4. To run establish open maintain libraries, laboratories workshop. Research centre of any type for the benefit of the students, teacher, staffs, scientist, members or society.
5. To engage teacher's professionals, professors, instructors, scientist and experts of good moral character, research scholar on such terms & condition as the management may think fit.
6. To carry on or conduct any type of research work invention in any field or may give any type of assistant, whether technical, monetary advisory or by any means to any person, association, institution, organization or Government.
7. To associate to get affiliation/ recognition / license from any university/ for the betterment off the trust & institution.
8. To invest, dispose of transfer and otherwise deal with the subject. Matter of the trust in such manner as the managing committee may think fit, so as to enable trust to Cary on the objects effectively.
9. To accept, receive, donation, grants presents, award, Gift Concession and other offering in any form and to deal with

the same for the purpose of the trust or can donate, give grant to any other institutions.



10. To charge tuition fees/fess and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or to be established by the trust.

11. To institute and award scholarship in India or abroad for study, research invention and apprenticeship for any student teacher or staff.

12. To purchase acquire, exchange, hire, lease any land, building, educational institution, hostel, hospital, clinic, auditorium, quarter, marketing complex, housing-complex, play-ground, library, research centre, laboratories or workshop and either retain the same in form or demolish the same or renovate, alter, construct, erect any structure on it for any object of the trust.

13. To organize, debates, lectures, exhibitions, expeditions, research works, dances, operas, theaters, outdoor, amusement, enterprises, public meetings & classes and conferences calculated directly or indirectly to advance the clause of education whether general, professional or technical.

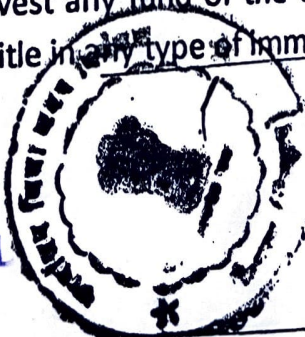

15. To open any type of account with any bank or financial institutions.

17. To invest any fund of the trust for institutions of any right, interest title in any type of immovable or movable properties

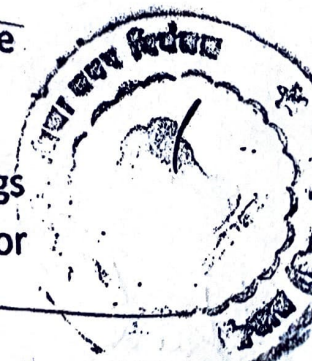

18. Trust is a CHARITABLE INSTITUTION as defined, in the INCOME TAX ACT.
19. Trust is a non-profit making institution and if during the course of any activities or business any profit or surplus will arise that shall be retained for the development of the institution/trust or shall be utilized in the manner as the board may think fit or as per law of the land, however under no circumstances this shall be utilized directly or indirectly for distributing as profit among members/board or committee or for their benefits, directly or indirectly.

21. For the benefit of the trust, the trust may raise any fund in any lawful manner.
22. The trust shall have every right to frame & make its rules and byelaws, it's constitution within the frame work of the law of the land.
23. Trust can carry on its objective and aims in any part of the world.
24. Trust may carry on or undertake any other work, things which board of trustees may decide from time to time for



direct/ indirect benefit of the institution or accomplishment of any object of the trust.

25. To open Sankar Kendra, school educational institutions, hostels in slums areas, Tribal Areas and along weaker section

of the society and to help, assist those persons/institutions who are working for the same objects for which the trust is authorized to do.

26. To work for the weaker section of the society and also for their betterment.
27. To work for rural development.
28. To work for the victims of natural calamities like flood, fire, Stormtornado etc.
29. To work for the students who have been dropped out and to tried them for their survival.
30. To establish book bank and publish literature for the betterment of the society.
31. To help the institutions which are working for the same course?

D. VALUE OF TRUST

(iii) The trustees may co-opt to the Board of Trustees, if necessary to make the total to Twenty one This is optional for Board and not mandatory.

(iv) A trustee shall cease to hold office of the trust if the trustee become insane or lunatic or insolvent or bankrupt or found guilty of moral turpitude or working against the interest of the trust.

F. POWER AND DUTIES OF THE BOARD OF TRUSTEES.

- (12) With the help of 2/3rd vote Board can suspend/dismiss any member of the executive Committee or any other committee or Board. It can dissolve any committee Board under any of the following conditions.

- (13) It may impose any terms, conditions or define any boundary line within which executive committee shall work.
- (14) Only Board can take any policy making or related decisions and this right cannot be delegated to any other committee or body.
- (15) Board may authorize to any Board/Committee except otherwise provided hereinbefore.
- (16) that meeting is to be called by giving. Three days notice.
- (17) That the Board of Trustees may nominate any person having interest in the educational activities as a Trustee.
- (18) That the Trustees are empowered to fill up the vacancy in the Board of Trustees.

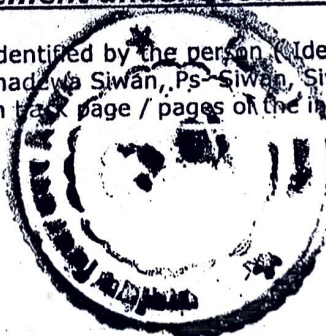
